The limits of global migration, together with the other specific restrictions to which the monomeries and other additives present in the material could be submitted to, are respected in the above mentioned conditions of use.

The affermation is supported by the analitic analysis executed in agreement with the DM 21/3/73 or in base of the done calculations considering the content of the substances submitted to the limits of migration.















The calculations are carried out assuming that 1kg of food gets in contact with 6dm² of packing material.
